# **NEW DATA SHOWS SURGE IN YOUTH E-CIGARETTE USE**

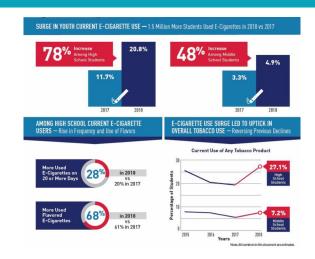
From 2017 to 2018, there was a 78 percent increase in the number of high school students who report using e-cigarettes, and a 48 percent increase in middle school students, according to the 2018 National Youth Tobacco Survey.

In addition to the increase in use, the survey results show an increase in the frequency of use and overall use of any tobacco product.

"This new data confirms the stories we've heard from students, parents, and schools over the past 12 months," said Kate Martin, Director of HLC.

The SUPP Coalition will be discussing this alarming trend, as well as other related topics at their next meeting on January 15.

### NATIONAL DRUG AND ALCOHOL FACTS WEEK 1/22 - 1/27

National Drug and Alcohol Facts Week (NDAFW) will be held January 22-27, 2019. This national health observance aims to shatter myths about drugs by linking teens to science-based facts about drugs and alcohol.

The initiative was launched in 2010 by scientists at the National Institute on Drug Abuse (NIDA) to promote educational events that engage youth in understanding the science behind drugs and addiction. Events are held at the community level, planned and hosted by local schools and organizations.

The Responsible Beverage Server Training was taught by Deputy Chief Rand Maker and Sgt. Mark Bridgham in Wiscasset at the Lincoln County Regional Planning Commission

On December 19, over 20 staff and managers of local bars, restaurants, and stores received training to help reduce underage drinking and drunk

Attendees from eight local businesses successfully completed the training, which covered Maine Liquor Laws as well as best practices for managing an establishment that serves or sells alcohol. Certification is provided from the Bureau of Alcohol Beverages and Lottery Operations and is good for three years.
