Dear Partners,
We've decided to shake up our newsletter structure a bit and will be kicking them off with an introduction. I think it's fitting that we are starting this in our last newsletter of 2021, as it provides us with a great opportunity to reflect on the happenings of the last year.

In 2021, Healthy Lincoln County was able to bring on Larissa Hannan as a substance use prevention coordinator to facilitate our Drug-Free Communities grant and harm reduction work. She reinvigorated our coalition and hit the ground running and secured our funding for Year 7. Over the summer we were awarded a grant through the Comprehensive Addiction and Recovery Act which allowed us to bring on another coordinator, Dona Lane to assist. It's been exceptional having a strong substance use prevention team, and I look forward to the growth of our work in 2022.

Through collaboration within our coalition, we have been able to coordinate a Sticker Shock event, multiple Responsible Beverage Server Trainings that reached numerous local businesses, develop a comprehensive parent survey, create a designated driver initiative with law enforcement, and hundreds of students were able to receive substance use prevention and resiliency training in their classrooms. We are also thrilled to announce that our SUPP Coalition graduated from the National Coalition Academy and are grateful for the participation of SUPP members who sat through many hours of training to make that happen. These are only a handful of many accomplishments from this past year, and ones we are exceedingly proud of.

Lastly, I want to extend a warm thank you to all of our exceptional community partners. From like-minded organizations, youth-serving entities, law enforcement, schools, local businesses, parents, and dedicated community members - this work would not be possible without you. You all are the heart and soul of this community, and we are incredibly humbled to have you take part in our mission to improve the health and well-being of our residents.

I hope you have a joyous holiday season. I look forward to our collaborations together in 2022.

# What's New at Healthy Lincoln County?

The Substance Use Prevention Partnership has GRADUATED from CADCA Academy!

As many of you are aware, Lincoln County's Substance Use Prevention Partnership (SUPP) has spent 2021 with the Community Anti-Drug Coalitions of America (CADCA) Academy, the sponsored organization of the Drug Free Communities grant, to guide awardees through skills and assessments related to successful coalition work. Larissa Hannan, our Substance Use Prevention Project Coordinator, attended the CADCA Academy with Kelsey Wollen, Rand Maker, Angela Arteaga and HLC Director Kelsey Robinson.

Recently, our coalition was notified that we have graduated from the academy, which not only is a notable feat in itself, but means that CADCA will notify the Drug Free Communities grant that our coalition has illustrated the appropriate skills to continue on with our grant funding.

## Sticker Shock: THIS FRIDAY

On December $17^{\text {th }}$, students from Lincoln Academy, along with Damariscotta Police Department, the Lincoln County Sheriff's Office, the CLC YMCA, and substance use prevention coordinators from Healthy Lincoln County will spend the afternoon placing thousands of bright orange stickers on packs of alcohol at four Damariscotta retailers.

They do this as part of an effort called "Project Sticker Shock" which aims to prevent underage drinking. Sticker Shock is sponsored by the Maine Office of Substance Abuse \& Mental Health Services and aims to reach individuals over age 21 who legally purchase alcohol and provide it to a minor. A team of youth, accompanied by adult chaperones and local law enforcement officers, will visit stores to place stickers on beer and other appropriate alcoholic beverages. The stickers are designed to remind adults who might purchase alcohol and then provide it to minors, which can result in fines up to $\$ 2,000$ and possible jail
time.
The results of a local youth substance use assessment show that over half of Lincoln County high school students think it would be easy to get alcohol if they wanted it, according to the 2019 Maine Integrated Youth Health Survey.
